# Spurs' revised plans for Bulls Cross

Spurs have resubmitted their planning application for a First Team Training Centre and Academy Facility on 23 hectares of Green Belt land to the west of Myddelton House at Bulls Cross. They have abandoned their initial plan to build also a community facility on Bulls Cross Open Space, presumably because they acknowledge that this is designated public open space. However the revised plans for the main site still show a massive building containing 12,000m<sup>2</sup> compared with the existing sports pavilion of 700m<sup>2</sup> which is to be demolished. There has been some reconfiguration and the footprint of the total complex has been slightly reduced, but the academy wing and the first team wing wrap around the south and east sides of the covered pitch and there is now a building mass with a length of 108m x 125m and a height varying between 8m and 9m. The maximum height of the covered pitch above ground level is 10.5m and with floodlighting columns 15m high it is hard to accept Spurs' contention that the complex will not be visible to the public, especially from the elevated position of Forty Hall.

The proposed siting of this structure is on agricultural land, which forms part of the historic Forty Hall Estate (owned by the London Borough of Enfield), is totally within the Green Belt, is within the Enfield Chase Area of Special Character and is on land which formed part of the 16th century deer park of Elsyng Manor House. For all these reasons the Character Appraisal for the Forty Hill Conservation Area, commissioned last year by our Council from a highly respected specialist consultant, recommends safeguarding this area by extending the Conservation Area to include all the remaining land under threat from Spurs.

This is clearly inappropriate development in the Green Belt and conflicts with the protection provisions contained in our Council's Unitary Development Plan. There would be unacceptable destruction of the topography of this historic landscape, long term disturbance of the present wildlife habitat and so many negative impacts on the area that it is inconceivable that the proposals can be justified on any grounds We continue to totally oppose Spurs' planning application.

We are keeping a watch on the regular maintenance programme to ensure that the requirements of the Heritage Lottery Fund are being met under the agreed 10 year Management Plan .

## Conservation

There are no new developments to report on Middlesex University at Trent Park issue. On the Spurs academy, a new application is just in, withdrawing the previous one, and Colin Pointer is giving our preliminary response on this. In Enfield Town the shape of the PalaceXchange shopping precinct is becoming clearer by the day, but the results are not any more pleasing. The lumpish, neo-50's blocks make no concession to their surroundings, either the earlier townscape or the existing Palace Gardens Phase I. Just published final proposals for landscaping the development do not look like softening the impact. Fewer trees are included than in the first draft and it is proposed to remove the planters in the square at the back of Pearson's, possibly to make way for some sort of eatery. At least the new traffic circulation appears to be settling down.

Pearson's have put in an application to change their shopfront. The Art Deco central feature will be carried right down to the ground, though not the similar features at each end as shown in their public handout – a pity. Also a pity is that the existing fascia will merely have a new and even deeper one stuck in front of it. Pearson's is such an important feature of Enfield Town, facing as it does the historic Parish Church and Market Place, but the application has now been approved despite our stated reservations.

Contrary to what I reported in the last News, Gentleman's Row is to be repaved in the standard grey ASP slabs, with grey blocks infilling the gaps.

It is now proposed to reassess the funding requirements and the possible sources of funds; HLF money will be sought only for the final phase of the project

## A Tale of Two Cedars

The Public Inquiry took place last month into the proposal to redevelop for housing landmark 'Highlands', the house opposite to Chase Farm behind the fine cedar trees. Most of the grounds went years ago; this was for the remainder. At the last Conservation Advisory Group Mike Brown, the new Conservation Team Leader, announced that the house had been added to the Local List of historic buildings and now comes the good news that the Inspector has dismissed the appeal. Any rejoicing would be premature, though, as the developer has just served notice of his intention to demolish the property in a month's time. This he is perfectly entitled to do, as the accompanying picture of 'Cedar House' (or what is left of it) along Green Lanes illustrates. This attractive house, also Locally Listed, was to be incorporated in a residential

development. A new planning application will now be needed to regularise the situation, but Local Listing has no power to prevent demolition. What is the use of it you may ask?

All too often with planning applications the work is carried out first and planning permission sought afterwards. In the case of Vicarage Farm, which includes the vital stretch of Green Belt countryside between the development along 'The Ridgeway' and Trent Park, extensive works, including a farm roadway, stable yard and other buildings, and also separately to rebuild and suburbanize two cottages as one were carried out and applied for retrospectively. In theory this should make no difference to the eventual decision, but experience tells otherwise. The major changes were refused permission, however, and we have just learned that the developer has gone to appeal.

## Heritage Link: Making Consultation Matter

Heritage Link has published the findings of its Why Bother survey, based on responses of nearly 200 heritage groups. This survey of voluntary sector experience of Local Authority planning consultation brings together comments from civic societies, CPRE groups, local archaeology groups and others. The overwhelming point was that heritage groups want to be involved in the planning process. They spend a great deal of time and effort responding to consultations on a huge range of proposals. They believe they can make a positive difference to the quality of lo-

cal and regional planning outcomes but confidence in the consultation process is variable. Effective participation is limited by capacity, poor communication, poor quality consultation documents and off-putting language. Consultations over Conservation Area matters are a particular concern. The capacity and resources of heritage groups often lags behind their aspirations and investment in these areas is critical to sustaining community involvement. Heritage Link will use the findings to draw up a strategy to improve the engagement process. Details are on its website www.heritagelink.org.uk.

## The President's Column

After an enjoyable and successful 70th Anniversary Dinner thoughts turn again to the future, more particularly on how is the Society to define its role in the face of changing circumstances? We have much to be thankful for. The EPS is involved in a wide range of activities and initiatives, with a substantial membership and a healthy bank balance. We have, at least in some quarters, a reputation for positive and balanced judgements. But there are some ominous clouds on the horizon. - The average age of our members steadily increases whilst membership numbers are static or slowly decreasing. A generation of activists are reaching the age when many will be looking to a younger one to take over their role but, in common with many societies, we are finding that younger people, whilst just as idealistically motivated, are

directing their interest to different aspects of the conservation movement or are just too busy working. For the first time ever we do not have anyone willing to undertake the role of Chairman. Our initiative to recruit corporate members met with very limited success. Only a limited number of our members play an active role, but this is the case with all societies and in fact our level of member participation one way or another is unusually high.

This leads to a number of questions. We have a very good website and a very informative newsletter and meetings at Jubilee Hall attract a wide attendance. But, are our efforts publicised sufficiently or to the right public? Do we project the right image? Should we as a Charity be looking at different initiatives or a new approach? Are we trying to do too much? Are there other ways to reach out to the

public, such as putting on exhibitions? Some things we should not change. We must remain free of all political bias. We must remain true to our basic aims and objectives. We must remain as rigorous as ever in criticizing the shoddy and mediocre and in opposing threats to our surroundings despite accusations of negativity. Tony Langston, who has himself sharpened the Society's focus on the street scene at a time when there is a growing awareness of its importance, has produced a paper looking at the problems as outlined and making some interesting suggestions.

It would be good to hear the thoughts and suggestions of members on this issue. The newsletter is always pleased to publish views, but we do get surprisingly little feedback.



## 70<sup>th</sup> Anniversary Dinner - 10<sup>th</sup> March 2006

An occasion to mark the founding of the Enfield Preservation Society in March 1936. Seventy members with guests, Tony Dev. Deputy Mayor of Enfield, and Margery Dey, Deputy Mayoress, Joan Ryan MP with husband Martin Haggerty and Mike Rye, Leader of Enfield Council with his Partner Gill Owen, sat down to an enjoyable meal, with background music provided by talented local entertainer, Chris Saussman. Tony Dey regaled the gathering with details of quirky sporting achievements from 70 years ago before proposing the toast to the Society. In reply, President, Chris Jephcott, having earlier welcomed the guests, reviewed the work and

achievements of the Society from its early days to the present, starting with the campaign to prevent a new Town Hall on the Library Green though to the outstandingly successful New River Loop project. We had had our differences with Enfield Council over the years, but also valuable co-operation and support. He summarized the activities of the various Groups and the Society's string of successful publications, before paying tribute to the debt owed by the EPS to a number of former members, sadly no longer with us. These included our late President Valerie Carter, and Don Gresswell, who donated to the Society its headquarters, Jubilee Hall, well used as a

meeting venue. The President went on to emphasise the hard work put in by many current members to maintain a successful organisation and also had warm praise for Beryl Dorrington and the Publicity Group for organising such a splendid event.

In conclusion he touched on the challenges facing the Society over the next seventy years, starting with the present - for the first time no current Chairman and a static or slowly declining membership. Finally, he also had one detail relating to 1936 that Cllr. Dey had not mentioned, namely that the Royal British Legion Hall, in which the anniversary event took place, also dated from that year.
